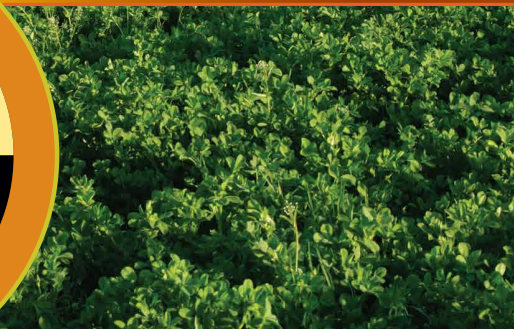

GENERAL INFORMATION: BorPower is used on field crops, fruit trees, vegetables, and ornamentals for the prevention and correction of Boron deficiencies. Use along with a regular fertilizer program for all crops requiring Boron. BorPower can be used with starter fertilizer.

MIXING INSTRUCTIONS: Put 1/3 to 2/3 of total water volume in tank. **1.** Add pesticide(s) if desired and agitate until thoroughly mixed. **2.** Add BorPower and agitate until thoroughly mixed. **3.** Add adjuvant(s) if desired and agitate until thoroughly mixed. Fill tank with remainder of desired water. A jar test is recommended for evaluating compatibility of BorPower with multiple product mixtures.

USE RATES (SOIL/FOLIAR/AERIAL): **SOIL:** 2–4 qt/acre. DO NOT place in direct contact with seed. **FOLIAR:** **Alfalfa:** 1–2 pt/acre. Apply BorPower at green-up and shortly after each cutting. Add 2 qt/acre of AlfaPower MP along with BorPower at green-up and shortly after each cutting to help maximize tonnage. **Field Crops, Tree Fruit, and Vegetables:** 1–2 qt/acre per application throughout the growing season. At least two applications are recommended. More frequent applications at higher rates may be needed to correct any deficiencies. **Ornamentals:** 1–2 qt/100 gallons of water. Cover foliage thoroughly to the point of runoff. Repeat applications if necessary. **AERIAL:** 1 qt/acre with a minimum of 2 gallons of carrier per acre.

NOTICE: Some crops may be injured by the application of Boron, and excessive amounts may be toxic.

KEEP OUT OF THE REACH OF CHILDREN: Avoid contact with skin, eyes, and clothing. Avoid breathing spray mist. Wash hands thoroughly after use. **Personal Protective Equipment:** Wear long-sleeved shirt and long pants, socks, shoes, and gloves.

FIRST AID: If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 minutes. **If in eyes:** Flush eyes immediately and thoroughly for at least 15 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eyes. **If swallowed:** Call a doctor or poison control center for treatment advice. Do not induce vomiting unless told to do so by the doctor or poison control center. Do not give anything by mouth to an unconscious person. **If inhaled:** Move the person to fresh air. If the person is not breathing, call 911, then give artificial respiration, if possible.

STORAGE AND DISPOSAL: Do not contaminate water, food, or feed by storage and disposal. Store in a cool, dry, locked area out of the reach of children. Protect from excessive heat or cold. Triple-rinse and dispose of container in accordance with local, state, and federal regulations.
