GENERAL INFORMATION: NutraTender is a fully chelated nutrient solution and is designed to be used as a foliar fertilizer for wildlife food plots, turf grass, pastures, and for use on any crop. NutraTender has an optimum blend of nutrients to supplement plant growth. NutraTender also includes a dormant spore-based liquid containing special secretions that are very beneficial to soil bacteria.

MIXING INSTRUCTIONS: Put 1/3 to 2/3 of total water volume in tank. **1.** Add pesticide(s) if desired and agitate until thoroughly mixed. **2.** Add NutraTender and agitate until thoroughly mixed. **3.** Add adjuvant(s) if desired and agitate until thoroughly mixed. Fill tank with remainder of desired water. A jar test is recommended for evaluating compatibility of NutraTender with multiple product mixtures.

USE RATES: Wildlife Food Plots: 3 oz/1000 square feet or 2–4 qt/acre. Apply 3–4 applications per season. **Turf Grass:** 3 oz/1000 square feet or 2–4 qt/acre. Apply 3–4 applications per season. **Grass Hay and Pastures:** 3 oz/1000 square feet or 2–4 qt/acre. Apply within 1 week after each cutting or as needed. **Fruits and Vegetables:** 3 oz/1000 square feet or 2–4 qt/acre. Apply every 7–10 days or as needed. **All Other Crops:** 3 oz/1000 square feet or 2–4 qt/acre. Apply up to 3 applications per season.

NOTE: Some crops may be injured by the application of Boron, and excessive amounts may be toxic.

KEEP OUT OF THE REACH OF CHILDREN: Avoid contact with skin, eyes, and clothing. Avoid breathing spray mist. Wash hands thoroughly after use. **Personal Protective Equipment:** Wear long-sleeved shirt and long pants, socks, shoes, and gloves.
